

**BYLAW NO. 2020-08  
VILLAGE OF KITSCOTY  
INCORPORATED IN THE PROVINCE OF ALBERTA**

**A BYLAW OF THE VILLAGE OF KITSCOTY IN THE PROVINCE OF ALBERTA TO AMEND UTILITY BYLAW NO. 04-2018 BY REPLACING SCHEDULE 'A' BEING THE MONTHLY WATER, SEWER, GARBAGE AND RECYCLE RATES OF THE VILLAGE OF KITSCOTY.**

**WHEREAS**, Section 7 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000 and amendments thereto authorizes a Council to pass bylaws for public utilities;

**AND WHEREAS**, Section 8 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 2000 provides for the amendment of a bylaw;

**AND WHEREAS**, the Council of the Village of Kitscoty deems it advisable to make provisions for the charging and collecting of water, sewer and garbage rates to meet the cost of maintaining and operating its water distribution and sewer collection system and garbage collection services

**NOW THEREFORE** the Council of the Village of Kitscoty, pursuant to the authority vested in it by the Statutes of the Government in the Province of Alberta, hereby enacts as follows:

1. Bylaw No. 04-2018, being the Utility Bylaw of the Village of Kitscoty is hereby amended.
2. That Schedule 'A', Monthly Water, Sewer, Garbage and Recycle Rates is hereby deleted in its entirety and replaced with Schedule 'A' Monthly Water, Sewer, Garbage and Recycle Rates attached to this Bylaw.
3. Bylaw No. 2020-04, being an amendment to Schedule 'A' Monthly Water, Sewer, Garbage and Recycle Rates is hereby repealed.
4. Should any provision of this Bylaw be determined to be invalid, then such provision shall be severed, and the remaining bylaw shall be maintained.
5. This Bylaw shall come into effect on January 1, 2021.
